Dear NAWO Member,

It has been a year full of surprises and changes across the world and across the UK. NAWO has continued its valuable work bringing together diverse organisations and providing a platform through which to lobby UK Government and participate in a variety of consultation papers and enquiries. We have also had joint events with members and partners across the Alliance. We look forward to new events and activities with members in 2017.

The NAWO Young Women's Alliance has grown in number and activity and we gained funding from ROSA to raise capacity of more young women to have their voices heard. Six young women received training in a variety of areas and conducted events, through which they shared information on SDG 5, to more than a hundred other young women. In addition some of their activities have the potential to reach hundreds of young people encouraging them to be activists for the equality of women and men, girls and boys. Two



events were held during the 16 days of activism as part of this project, one in the House of Commons chaired by Roberta Blackman Woods MP and the other in the House of Lords chaired by Baroness Verma. The young women also wrote to MPs and wrote blogs. A full report will be available on the NAWO website [here](#).

The European Network meeting series was updated and we held a number of events through the year. We have an exciting set of meetings for 2017. Please do join us, invite all of your members, offer us speakers and advertise them to others. A list of dates will be sent through in the new year.



NAWO continues its role as Secretariat of the UK NGO CSW Alliance, although we do not have funding for this work at this time, though we hope to gain some in 2017. At CSW this year, NAWO had three very successful events, as well as supporting many others. We had active participation of the YWA with a delegation of 16 young women attending CSW and speaking in a variety of events. We anticipate this presence at CSW continuing into 2017 with three events planned in addition to those we support. There is a YWA delegation of 25 young women and men also attending. NAWO provided information on Europe, giving evidence on our website of the value of Europe and held an event at Europe House in February on the arguments for staying in the EU. Post June, NAWO hosted an event, again at Europe House, to bring together women's organisations to consult on the way forward post Brexit, in collaboration with EWL. NAWO took part in the campaign to ratify the Istanbul Convention, putting forward names of partners in Wales, Scotland and Northern Ireland for the ICChange expert group. We encouraged members to be involved, worked on the executive group, participated in photo shoots, events in parliament, the doll activity and we were at the event in parliament on 16 December. NAWO continues our membership of the UK Joint Committee on Women (UKJCW) made of sister organisations in the three devolved countries with us, and through that to the European Women's Lobby. Barbara Cleary, NAWO Vice-Chair, has been elected onto EWL board and is the current UKJCW representative. NAWO continues strong links with EWL, continuing to campaign for a Europe Free from Prostitution. One of our YWA is part of the EWL youth for abolition group.
